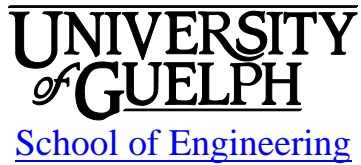

## 4 AIMS, OBJECTIVES & GRADUATE ATTRIBUTES

### 4.1 Calendar Description

Physical properties of natural and synthetic (e.g. stainless steel, polymers) materials used in biological engineering applications. Topics will include microstructure and mechanical properties of typical biomaterials, quantification of advanced material properties and behaviours, fabrication, compatibility, biodegradation and mechanical failure. Typical applications will include processing of biomaterials as well as equipment and implant design.

*Prerequisite(s):* ENGG\*2120

### 4.2 Course Aims

This course is an introductory course in biomaterials, examining the materials used in biomedical and biological applications, and the materials that they are replacing such as bone, cartilage and ligament. The mechanical, chemical and physiological considerations for the use of these materials in medical applications will be examined. As well, design implications for the use, manufacture and processing of

these materials will be covered. Finally ethical considerations as an engineer employed in this industry will be covered.

### 4.3 Learning Objectives

At the successful completion of this course, the student will have demonstrated the ability to:

1. Apply knowledge of design considerations for processes for extraction, synthesis and processing of materials to meet technical constraints.
2. Analyze materials engineering problems specific to biomedical applications using a balance of mathematics, physics, chemistry, and physiologic considerations.
3. Demonstrate a working knowledge of general properties (mechanical, chemical, physiological) of both synthetic and natural materials used in biomedical and biological engineering applications.
4. Predict the stress/strain/time response of biological materials using mathematical equations.
5. Demonstrate competency in using materials testing equipment to obtain mechanical properties of biological materials.
6. Appraise and critique current methods of testing/standards required for the development of biomaterials in medical applications; including ethical issues involved.
7. Communicate effectively in a professional environment through technical reports and presentations.
